CONDITIONS AND REQUIREMENTS FOR DRIVING SAFETY COURSE

CONDITIONS: YOU MUST CONTACT THE COURT BEFORE YOUR COURT DATE ON YOUR CITATION TO BE ELIGIBLE FOR A DRIVING SAFETY COURSE

1. CDL holders ARE NOT ELIGIBLE FOR THE DRIVING SAFETY COURSE (DSC)
2. Driving at a speed of 95mph or more NOT ELIGIBLE
3. Driving 25mph or more over posted speed limit NOT ELIGIBLE
4. Speeding in a work zone with workers present NOT ELIGIBLE
5. Drivers who have taken a DSC in the last 12 months NOT ELIGIBLE
6. Drivers who are currently taking a DSC for another ticket NOT ELIGIBLE
7. YOU MUST HAVE A VALID TEXAS DRIVER LICENSE

REQUIREMENTS:

Enter a plea of No Contest or Guilty and Request a Driver Safety Course before the court date on the citation and send the following Original Documents to the Court:

1. COPY OF DRIVER'S LICENSE (NON-COMMERCIAL ONLY)
2. COPY OF CURRENT INSURANCE
3. COPY OF CITATION
4. PAYMENT OF \$157.00 (Payable to Crane County Justice of the Peace) NO PERSONAL CHECKS ACCEPTED / MONEY ORDERS or CASHIER'S CHECK ACCEPTED / DEBIT or CREDIT CARDS ACCEPTED – CALL THE COURT CLERK
5. CERTIFIED COPY OF DRIVING RECORD (TYPE 3A) YOU MAY GET ONLINE @ <http://www.dps.texas.gov/DriverLicense/driverrecords.htm> (COPY AND PASTE IN BROWSER)
