

**ORDER ADOPTING TAX RATE**

After notice and hearing, the following motion was offered by Domingo Escobedo, Commissioner Pct. 3 and seconded by Ruby Martinez, Commissioner Pct. 4 "I move that property tax rate be increased by the adoption of a tax rate of 0.830000 , which is effectively a 48.4 percent increase in the tax rate."

**"THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE RAISED BY 48.4 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$271.02."**

And, among other proceedings had by said Court were the following:

Commissioner Domingo Escobedo introduced the following order and moved its adoption by the Court;

WHEREAS, the Commissioners' Court of Crane County, Texas has heretofore approved and adopted the County Budget for the fiscal period beginning October 1, 2016 and ending September 30, 2017, And WHEREAS, it is now decreed necessary and advisable that the Commissioners' Court set the various tax rates to be levied against all taxable property on the 2015 tax roll for Crane County, Texas.

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS' COURT OF CRANE COUNTY, TEXAS,

That the tax rate to be levied on all taxable property of Crane County, Texas, for the fiscal period 2016 shall aggregate .830000 on the \$100.00 valuation of all taxable property shown on the 2016 tax roll, as heretofore adopted and approved by Commissioners' Court.

That the said County Wide Tax Levy, aggregating .830000 on the \$100.00 valuation, shall be and the same is hereby specifically levied for the following rates:






