

ORDER ADOPTING TAX RATE

After notice and hearing, the following motion was offered by Young, Commissioner Pct. 2 and seconded by Escobedo, Commissioner Pct. 3 "I move that property tax rate be lowered by the adoption of a tax rate of 0.772729, which is effectively a 0.93 percent decrease in the tax rate."

"THIS TAX RATE WILL LOWER TAXES FOR MAINTENANCE AND OPERATIONS COMPARED LAST YEAR'S TAX RATE. THE TAX RATE WILL EFFECTIVELY BE LOWERED BY 0.93% PERCENT AND WILL LOWER TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$7.27."

Commissioner Young introduced the following order and moved its' adoption by the Court;

WHEREAS, the Commissioners' Court of Crane County, Texas has heretofore approved and adopted the County Budget for the fiscal period beginning October 1, 2018 and ending September 30, 2019, And WHEREAS, it is now decreed necessary and advisable that the Commissioners' Court set the various tax rates to be levied against all taxable property on the 2018 tax roll for Crane County, Texas.

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS' COURT OF CRANE COUNTY, TEXAS,

That the tax rate to be levied on all taxable property of Crane County, Texas, for the fiscal period 2018 shall aggregate .772729 on the \$100.00 valuation of all taxable property shown on the 2018 tax roll, as heretofore adopted and approved by Commissioners' Court.

That the said County Wide Tax Levy, aggregating .772729 on the \$100.00 valuation, shall be and the same is hereby specifically levied for the following rates:




COUNTY JUDGE, CRANE COUNTY, TEXAS




COMMISSIONER, PRECINCT ONE

COMMISSIONER, PRECINCT THREE




