You **MAY** be eligible to take a **DRIVER SAFETY COURSE**, qualifications are as follows:

Drivers Safety Course (Defensive Driving)

CONDITIONS:

- CDL holders are not eligible for the Drivers Safety Course (DSC)
- Driving at a speed of 95 mph or more not eligible for DSC
- Driving 25 mph or more over posted speed limit not eligible
- Drivers who have taken a DSC in the last 12 months are not eligible
- Drivers who are currently taking a DSC for another ticket are not eligible

REQUIREMENTS:

Enter a plea of Guilty or No Contest on or before the answer date on the notice to appear
Request Drivers Safety Course within the allowed time of the violation date and send the following:

1. Copy of Driver's License (Non-commercial only)
2. Copy of Current Insurance
3. Copy of Citation
4. Payment of \$135.00 (Payable to Crane County Justice of The Peace) NO PERSONAL CHECKS
5. Certified copy of driving record (Type 3A) from: www.txdps.state.tx.usDriversLicensedriverrecords.htm
6. Signed and notarized affidavit below
7. Mail or Bring to Court BEFORE OR BY APPEARANCE DATE ON CITATION
8. DO NOT TAKE DSC UNTIL YOU RECEIVE APPROVAL LETTER FROM THE COURT
