And, among other proceedings had by said Court were the following:

Commissioner YOUNG introduced the following order and moved its' adoption by the Court;

WHEREAS, the Commissioners' Court of Crane County, Texas, has heretofore approved and adopted the County Budget for the fiscal period beginning October 1, 2025, and ending September 30, 2026, And WHEREAS, it is now decreed necessary and advisable that the Commissioners' Court set the various tax rates to be levied against all taxable property on the 2024 tax roll for Crane County, Texas.

NOW, THEREFORE, BE IT ORDERED BY THE COMMISSIONERS' COURT OF CRANE COUNTY, TEXAS,

That the tax rate to be levied on all taxable property of Crane County, Texas, for the fiscal period 2025 shall aggregate .812929 on the \$100.00 valuation of all taxable property shown on the 2025 tax roll, as heretofore adopted and approved by Commissioners' Court.

That the said County Wide Tax Levy, aggregating .812929 on the \$100.00 valuation, shall be and the same is hereby specifically levied for the following rates:
