ORDER PROHIBITING CERTAIN FIREWORKS  
IN UNINCORPORATED AREAS OF CRANE COUNTY, TEXAS

WHEREAS, the Texas Forest Service has determined that drought conditions exist in Crane County; and

WHEREAS, on the 8<sup>th</sup> of June 2021, the Commissioners Court of Crane County has determined that the normal danger of fire in the unincorporated areas of Crane County is greatly enhanced by the extremely dry conditions now existing;

NOW, THEREFORE, the Commissioners Court of Crane County adopts this Order prohibiting the sale or use of restricted fireworks in the unincorporated areas of Crane County.

- A. A person may not sell, detonate, ignite, or in any way use fireworks classified as "skyrockets with sticks" under 49 C.F.R. part. 173.100(r)(2) (10-01-86 edition) or missiles with fins in any portion of the unincorporated areas of Crane County.
- B. This Order does not prohibit:
  - 1. common fireworks, small in size classified as Class C explosives;
  - 2. large fireworks devices designed primarily to produce visible or audible effects by combustion, deflagration, or detonation and classified as Class B explosive by the U.S. Dept of Transportation (TEX.OCC.CODE, Chapter 2154).
- C. This Order does not prohibit "permissible fireworks" as authorized in Occupations Code Section 2154.003(a).
- D. A person commits an offense if the person knowingly or intentionally violates a prohibition established by this Order. An offense under this order is a Class C. Misdemeanor.
- E. This order expires on the date the Texas Forest Service determines drought conditions no longer exist in the county or June 24<sup>th</sup> midnight, July 4, whichever is earlier.

The Crane County Commissioners Court designates the area immediately South of County Court Road as a safe area for fireworks. North of Northside Community Building


